 - The Public Comment Period is a total of **15 minutes** (City Ordinance 2007-1090-D)
 - There is a 3-minute time limit per speaker.
 - No format action can be taken.
 - **POWERPOINT PRESENTATIONS ARE NOT CONDUCTED DURING THE PUBLIC COMMENT PERIOD.**
