- Commented on some major projects; the Sam's pool deck repair in process, Paseo De La Resaca clean up, playgrounds being installed at different locations, etc.
- Gave a brief status on the Oliveira pool, which will need to be tracked on the amount it is used, funding and replacement and do a report for the City Manager to decide if to proceed on replacing it.

8. Safety Concerns (Parks Advisory Board)
